## EXHIBITION RULES

### 1. EXHIBITION DETAILS

GLOBE TROTTER sas di Villani Sonia & C. with registered office in Ferrara, Via Maria Majocchi Plattis 5C, Italy, VAT IT01863670384, henceforth called "Organiser", in partnership with FEDERUNACOMA – National Federation of the Agriculture Machine Producers – with registered office in Bologna, Viale Aldo Moro, Torre I n. 64 – 40127 Bologna (BO), organises the Exhibition ENOLIEXPO ADRIATICA, henceforth called "Exhibition".

Thanks to this collaboration, the commercial activity of sale of spaces and the management of exhibitors of Agriculture Machines (including accessory equipment for tractors), will be managed by Globe Trotter sas together with FEDERUNACOMA.

The Exhibition will be held from 19<sup>th</sup> to 21<sup>st</sup> March 2026, in the Exhibition venue NUOVA FIERA DEL LEVANTE in Bari - Italy.

The Exhibition is only open to professional visitors.

The opening hours for visitors are from 9,00 AM to 6,00 PM.

Admission is free only for professional visitors, after registration.

Exhibition dates are decided by the Organiser, who has full faculty to change dates and the duration of the Exhibition without incurring any liability.

ENOLIEXPO ADRIATICA is an ISFCERT certificated exhibition (Accredia) and it is recognized as **INTERNATIONAL EXHIBITION** since the 2022 edition, with equal qualification for the 2024 edition.

### 2. ADMITTED PRODUCT CATEGORIES

The Exhibitors, Italian and Foreign companies, are manufacturers of products, trade agents and sales representatives or dealers.

Dealers and sales representatives are requested to specify in the catalogue entry application form the brands they represent and the products they are exhibiting.

The Exhibition is open to companies operating in the following macro-categories :

- AGRICULTURE: viticulture, olive growing
- TRANSFORMATION TECHNOLOGIES: oenology (winery), olive oil industry (oil mill)
- END-OF-LINE
- PACKAGING HANDLING LOGISTICS
- SERVICES

Since the 2024 edition, the **BEERTECH** sector, dedicated to raw materials and technologies for the production of craft beer, has been present.

The Organiser has the sole and absolute discretion in relation to the admission of Exhibitors and allocation of exhibition areas; admission is guaranteed within the limits of available space.

#### **4. SECURITY IN THE FAIR AREA AGAINST ROBBERIES – RESPONSIBILITY FOR THEFT AND DAMAGES – DISCLAIMER FIERA DEL LEVANTE AND ORGANIZER– ALL RISKS INSURANCE EXTENSION**

During Fair opening hours, the Exhibitor is required to supervise his stand with dedicated staff.

During the assembling and disassembling phases the Exhibitor is responsible for the materials, goods and furniture elements of his area, as well. Fiera del Levante and the Organizer are exempted from every responsibility in case of damage and/or robbery, even if a continuous night and day security service for the entire duration of the Fair and the assembling and disassembling periods, is provided.

Moreover, the Exhibitor is responsible towards Fiera del Levante for direct and/or indirect damages which could be attributed to him for any reason (including damages caused during the assembling or disassembling phases).

As responsible for his goods safekeeping, the Exhibitor holds harmless both essentially and processually Fiera del Levante and the Organizer, keeping them free from any loss, damage or responsibility (including legal fees), consequent to the use of the stand or the assigned area.

Otherwise, the Exhibitor benefits from the following insurances taken out by the Organizer (included in the participation fee):

##### **- All Risk Insurance – Storage** (including Fire and theft insurance)

All the goods present inside the stand (furniture, installation, equipment and goods) will be guaranteed up to the amounts indicated in the policy against all direct and material damages. Dexterity thefts (that is to say thefts committed during the Fair opening hours in presence of the staff in each stand) are also guaranteed, up to a maximum amount of € 500,00 for each single Exhibitor, with a lower threshold of € 100,00 for each claim. Shortfalls noticed after the end of the Exhibition, damages caused by acts of terrorism during the storage, failures of any kind, assembling and disassembling of machineries, electronic systems and equipment are not included.

##### **- All Risk Insurance – Transportation**

This insurance is meant to be valid from the moment when the goods leave the Exhibitor's storehouse and/or depot, continues during the journey and ends with the delivery back to the company. The insurance applies also during the return journey, only in case the goods be correctly packaged.

##### **- Exhibitor's Third party civil responsibility**

The above mentioned insurance covers are regulated by the conditions and limitations that the Exhibitor can claim to the Organizer, and that will be reported in the technical form available at the Organizer office or on the website.

#### **5. SALES OF GOODS**

No retail sales are allowed in the exhibition.

#### **6. MACRO SECTORS AND MACHINERIES**

The admitted products at **ENOLIEXPO ADRIATICA** are those mentioned in the Product index, summarized in the following macro- categories:

- **AGRICULTURE:** *viticulture, olive cultivation: Plant nursery, products for vineyard treatment, machineries and tools for vineyard treatment, tools for grape harvesting, products, machinery and tools for olive groves, tools for olive harvesting, tractors, trailed and mounted machines*

- **PROCESSING TECHNOLOGY AND SERVICES FOR WINERY AND OIL MILLS:** *winemaking technology, oenology, oil production, machinery and equipment for grape and olive processing, accessories, flooring and coverings, containers and storage materials.*

- **PACKAGING, HANDLING AND LOGISTICS:** *machinery, products and services for packaging and shipping products*

- **SERVICES:** *specialized press, trade fairs, institutions, trade associations.*

There is also the **BEERTECH** sector, dedicated to the beer craft production and divided into macro-categories:

- **RAW MATERIALS:** *malt, hop and yeasts*

- **TRANSFORMATION TECHNOLOGIES:** *plants for distillation, fermentation, pasteurization and filtration*

- **END-OF-LINE:** *machineries and plants for bottling, corking, capping, labelling, machineries and products for packaging*

Machineries and tools must have CE mark and comply with safety standards according to the laws.

Machineries can be put into operation but must not be dangerous for exhibitors and visitors.

Therefore, such machineries must be equipped with devices that prevent injuries, damages, gas emissions, foul odours or fluid dripping. According to the rules of Nuova Fiera del Levante, it is forbidden to bring into the Exhibition venue explosives, detonators, choking or inflammable materials or otherwise dangerous materials, without previous authorisation from competent authorities and Organiser.

Exhibitors of agricultural vehicles or other machineries containing fuel must empty tank from all kinds of fuel.

## 7. **RULES OF PARTICIPATION**

### a. **Rules of Participation for the Exhibitor**

The Application Form is a document that regulates application to Exhibition. It must be filled in, signed and sent by email: [info@enoliexpo.com](mailto:info@enoliexpo.com) or by post to Globe Trotter sas, complete with Rules and Privacy Policy.

This document constitutes an irrevocable proposal for the applicant, which will imply acceptance by the applicant of the 'General Regulations' and must be accompanied by proof of payment of the deposit.

Minimum area of stand to participate is 16 sqms, a part special requests according to space availability.

Applications forms must be delivered within 31/01/2026.

### b. **Non-acceptance by the organiser**

Rejection of application by Organiser gives right to the Exhibitor to full refund of deposit.

### c. **Cancellation participation by the Exhibitor**

Exhibitors who cannot participate to Exhibition due to documented inability, can request to the Organiser the cancellation the contract by sending a written request by registered mail [gtrottersas@pec.it](mailto:gtrottersas@pec.it) (or via mail to [info@enoliexpo.com](mailto:info@enoliexpo.com) for Foreign companies) which must be delivered within 31/12/2025. In this case the whole amount of deposit will be refunded.

If cancellation is submitted after such date, participation cost must be entirely paid by Exhibitor, and Organiser has faculty to allocate exhibition area to another company. Also in case of partial cancellation of assigned stand place, in case this space cannot be allocated to another exhibitor, applicant Exhibitor must pay the whole amount of participation cost. Organiser can also decide to require compensation for other losses caused by withdrawal from participation.

In the event of a dispute or other contestation of liability, the parties will initiate a conciliation procedure. If this is not possible, the Court of Law of Ferrara will have jurisdiction on such matter.

## 8. **TERMS OF PAYMENT**

Application Form must be submitted together with payment of Deposit.

### **Rebooking or Priority Fee**

A Rebooking rate (for the 2024 Exhibitors) and a Priority rate (for the new Ones) expiring on 30/04/2025, is reserved to those companies registering within this date. To these companies (the date of arrival of the application form will count) is reserved a payment method with the following deadlines:

I Advance Paym. 20% at the Registration     II Advance Paym. 20% on 30/09/2025     Balance 60% on 13/02/2026

### **Full Rate**

For exhibitors registering from 01/05/2025 (the date of arrival of the application form will be decisive), the method payment is:

Advance Paym. 20% at the Registration     Balance 60% on 13/02/2026

Organiser reserves the right to accept applications submitted without payment of deposit.

Balance of participation fee must be paid within and not later than 13/02/2026.

If balance is not paid, Organiser can reject admission of exhibition materials into the exhibition venue.

During Exhibition days, Organiser delivers balance of invoices issued directly to the assigned stand.

The payment of services requested during the exhibition can be made on site.

Only upon payment of due amount, the "Exit Pass" will be given to the exhibitor, who will hand it to surveillance staff at the exit.

## 9. **EXHIBITION AREAS**

Exhibition areas are allocated according to product groups and, when possible, according to chronological order of applications. Exhibiting spaces will be marked by adhesive tape or lines on the ground inside the exhibition venue.

### a. **Location of exhibiting spaces – Assembly**

Granting of exhibiting spaces is at sole and absolute discretion of Organiser, who will send Exhibitor a proposal for a exhibiting space that will try to comply with that requested in the Application Form, in respect with availability of spaces. For technical and organizational reasons, Organiser has the right to change (enlarge or reduce) the space requested by Exhibitor, without incurring in any liability.

Bare areas to be customized will be available for Exhibitors from 16/03/2026.

The pre-equipped areas will be ready on 18/03/2026.

The building times are from 8,00 AM up to 7,00 PM.

Sub-contracting, even for free, or subleasing of all or part of exhibition area, is strictly forbidden.

Hosting of other companies at own exhibition area is allowed only in compliance with specific co-exhibition regulations and must be previously approved by Organiser.

Organiser can decide how to use exhibition areas and stands that have not been occupied upon opening of exhibition even if they have been regularly reserved.

Any exhibition of other products not included in the Catalogue Entry Application Form, or by other manufacturer, as well as any form of advertisement made for another company, is forbidden. Any exhibition of other products not included in the Catalogue Entry Application Form, or by other manufacturer, as well as any form of advertisement made for another company, is forbidden.

### b. **Return of exhibiting spaces - Dismantling**

At the end of Exhibition and not before closing time, exhibitors can remove products and materials displayed and take them out of the exhibition area, after collecting Exit Pass from Organiser.

Moving out works can take place for hand-carry items from 6,30 PM to 8,00 PM on Saturday 21/03/2026.

On the following days 22<sup>nd</sup> e 23<sup>rd</sup> March 2026 the hours for moving out materials and disassembly of stands is from 8,00 AM to 7,00 PM.

### c. **Customized areas**

Customized areas for Exhibitors, who request the sole exhibition area to Organiser, must be contained within the area of exhibition space assigned. Such stands must comply with the laws regarding safety and fire prevention. Exhibitors must carry a technical compliance report for electrical system and fittings, signed by a registered technician, according to the laws C.E.I. 64/8 and 64/10.

Maximum height for stands is mt. 3 and the free sides of exhibiting spaces cannot be covered by panels exceeding 50% of side's size.

Ceiling Hanging and suspensions are not allowed.

Creation of mezzanine floors must be authorized by the organization.

In case it is necessary to use particular fittings or make changes, Organiser has faculty to approve or reject exhibitor's request.

Exhibitors requesting the sole exhibition area to Organiser must submit project of stand decoration within **09/02/2026**.

The Exhibitor may have his stand erected only after submitting the project to the Organiser and receiving approval for construction. Organiser reserves the right, in absence of project submission, to charge Exhibitor for changes or partial or complete removal of unauthorised installation which, according to Organiser's undisputable judgment, are against the rules or may affect the aesthetics of the exhibition hall or the exhibitors or the visitors.

Organiser can also provide quotations for customised installations.

Exhibitor, in compliance with art. 26 of D.Lgs. 81/08, must check technical and professional eligibility of contractors appointed and will provide detailed information on risks of workplace. Exhibitor also acknowledges understanding of the "Technical Regulations" of Nuova Fiera del Levante, accepting its contents and committing to provide a copy of such documentation to appointed contractors.

**10. OTHER INFORMATION**

- a. Organiser is in charge of printing and distribution of a Visitor's Guide with the list of exhibitors and exhibited products, in alphabetical order. The complete Exhibitors' catalogue will also be on the site. Organiser is not liable for incorrect information provided by Exhibitor or typing errors or layout errors.
- b. Advertising is allowed with prices decided by Organiser
- c. Any kind of advertisement outside stand space or through distribution of leaflets is forbidden.
- d. Supplies of goods can be delivered to the stands from 8,30 to 9,00 AM during the 3 Exhibition days and must be done at the presence of a member of surveillance staff. It is forbidden to take out displayed goods before end of Exhibition.
- e. Banners are allowed, as well as posters and advertisement inside own exhibition area; beams of light with advertisement projected onto ceiling or aisles are forbidden. For Exhibitors, Represented Companies and Co-exhibitors, as long as they are registered at Exhibition, advertisement is allowed only inside own exhibition space. The use of multimedia devices must not disturb neighbouring exhibitors with high volume. Copyright costs (SIAE) for use of music and video clips are to be paid by Exhibitor.
- f. Visitors and exhibitors cannot take pictures inside Exhibition, unless authorised by Organiser.

**11. CANCELLATION AND INTERRUPTION**

In case of unforeseen circumstances the Organizer can change the Exhibition details and, if necessary, cancel the Exhibition.

In case the Exhibition cannot be held, due to unforeseen circumstances and/or to reasons independent of the will of the Organizer (for example, but not as a complete list: war, riot, fire, strike, natural disaster, epidemic outbreak, compulsory administrative measures of the site on behalf of a competent authority with power in regard to security, temporary or permanent stop dispositions coming from the Government or other institutional bodies), the Organizer will be entitled to cancel the application forms and to refund the Exhibitors with the remaining available amounts, in proportion to the previously paid sum by every single Exhibitor, after deducting the hold costs.

This article is also applied in case of interruption of the running Exhibition.

**12. AMENDMENTS TO THE REGULATION**

The Organizer reserves its right to provide norms and dispositions suitable to regulate the Exhibition and the related services, by way of derogation from the present regulation.

These eventual changes have the right of compulsoriness which the Exhibitors are obliged to stick to.

In case the Exhibitor is not inclined to respect the rules required by the Organizer, the expulsion and the loss of the refund of the previously paid sums are foreseen.

**13. PRIVACY**

The Exhibitor authorizes the treatment of the a.m. data (as per the art. 13 of the Legislative Decree n. 196 of 30th June 2003 – Italian Law and in compliance with the art. 13 and 18 of the European Privacy Rules UE/2016/679 - DGOR) regarding security and integrity of the data, for purposes regarding the development of the Exhibition ENOLIXPO Adriatica.

Policy statement on Article 13 of Legislative Decree no. 196 of 30 June 2003 (Code regarding the protection of personal data)

### 1. Purposes of processing
